

Nature Park - Phase I

- Improve and repair nature trail, observation points, fishing pier, drainage, and ADA accessibility
- Construction may occur in phases to accommodate other priority projects; 100% plans received; permitting is in process
- Will continue to look for grant opportunities
- Park Impact Fees and Sales Tax Funds (ADA)
 - Project Budget \$536,000
 - Engineering \$181,000, Construction \$355,000



Bridge Repair

- Projects are a result of FDOT bridge inspections
- Biennial Inspections continue. General repairs completed by right-of way.
- Inspections were performed after Hurricane Milton by Florida Department of Transportation (FDOT) and given the okay.
- Underwater inspection and repairs to be completed in FY 2025.
- General Fund
 - \$68,000



Downtown Flooding Improvement (Phase III)

- General Funds to complete an engineering study to provide possible solutions and estimates
- Special Use funds for construction of chosen solution. Additional funding may be needed



Drainage Improvements – Boca Grande Area


- Drainage improvements for Corto Andra/Boca Grande area; may include a retention pond bank
- Maintain a defined level of service which requires that water not stand in swales more than 72 hours following the last rainfall
- All property acquired; State appropriation, federal grant, and Southwest Florida Water Management District grant awarded
- Final plans, technical specifications, engineers opinion of probable cost of construction received
- Staff has updated the master drainage agreement with the railway.
- Working with the consultant and state to complete the Environmental Review Record
- Sales Tax; State Appropriation; Grant Funding
 - Current project budget \$7.4 million



Channel and Basin Dredging at Boat Club Area

- Dock removal complete
- Channel and basin have silted in
- Permitting is complete.
 Project delayed due to hurricanes and damages to docks
- General Fund
 - Project Budget \$40,000
 - Unfunded \$200,000 (reapply for grant)



Railroad Crossing Rehabilitation

- Mandatory rehabilitation improvements per agreement with Seminole Gulf Railway, LP
- FY 2026: Elizabeth Street crossing and sidewalk
- FY 2027: Ann Street crossing (no sidewalk)
- Public Works (PW) coordinating with the railway to obtain the preliminary design; delays are likely due to railway projects related to the hurricanes.
- General Funds
 - \$450,000 for Elizabeth St
 - \$300,310 for Ann St




Laishley Fishing Pier and Seawall

- Engineering study completed
- Replace decking, pilings need jackets, pile caps need sealing, and sidewalk needs to be jacked again.
- Additional damage was sustained in the most recent hurricanes. Engineer will need to review for any changes to structural elements and revise repair costs
- Will submit additional damage to FEMA for consideration for 75% reimbursement
- Special Use Funds
 - \$1,070,000



Sidewalk Improvements

- 15
- Construction of additional sidewalks throughout the city, providing for safe pedestrian traffic
- Henry St sidewalk
 - Permitting continues
- Other projects to be determined by priority and may include Historic District infrastructure, complete street improvements West Henry St. connection, US 41 NB bridge underpass improvements, and others
- Sales Tax Funds and Impact Fees
 - \$462,000



King Street Improvements





Henry Street Crosswalks

- Evaluate locations for installing signalized pedestrian crossings, crosswalk placements, removals and pedestrian refuge islands in area from Coldeway Dr to Linear Trail bound by Marion, Olympia and Henry St and then construct improvements
- Submitted for the bid process
- Sales Tax Funds
 - Project Budget \$539,000



Complete Streets – Shreve Street Improvements

- FY 2021-2025 Lighting on the Shreve Street path from Airport Road/Pompano Terrace to History Park
- Tried to contract with an engineer in past but came in too high just for design. Public Works reviewing for alternative design options.
- FY 2025 Widen the path on Pompano Terrace from Shreve Street to US 41
- Sales Tax Funds
 - \$355,000 funded
 - \$90,000 unfunded



Complete Streets – Virginia Ave (US 41 to Nesbit)

- Design and Construct improvements for sidewalks, crosswalks, parking, lighting and trees
- Council direction to move forward with parking only; Urban Design and Public Works to review plans for appropriate changes
- Sales Tax Funds
 - o \$1.1 million



ADA Curb Improvements/Intersection Treatments



- ADA improvements/ intersection treatments are being completed to alleviate ADA issues. May be constructed in conjunction with resurfacing program at required locations
- Will evaluate crosswalks with the FY 2024 and 2025 paving program for possible improvements

Historic City Hall Rehabilitation

- Also possible purchase of another facility was discussed
- Sales Tax, Special Use, Insurance Proceeds, and Sale of Belaire Ct Funds
 - o Project budget \$15.9 million



AC Freeman House Preservation



- Rehabilitation and remediation of this building while maintaining its historic character
- City Council direction to stabilize the envelope of the building
- Sales Tax, Insurance Funds, and Grant award
 - o Project Budget \$1.4 million



Henry Street Property Improvements


- Design enhancements to include:
 - Hounds on Henry
 - Peace River Wildlife Center (PRWC) connectivity to History Park, Library, and Linear Park
- Restroom facilities, parking, pathway connections, landscape
- Construction nearing completion on parking lot and drainage
- Park improvements to be completed after PRWC completed
- Sales Tax and Impact Fee Funds
 - Project budget \$ 3.2 million (\$1.2 million unfunded)



Harborwalk – ADA US 41 SB Bridge Ramp



- Harborwalk ADA ramp designed to PPM standards at the US 41 SB Bridge
- This project will be undertaken by FDOT with construction in FY26
- City standard decorative upgrades
- Sales Tax Funds
 - \$90,000



Living Shoreline Tiki Point at Harborwalk

- This is a multi-year project consisting of planning, design, engineering, and construction of a living shoreline along a segment of the City's Harborwalk for resiliency planning
- Working with granting agency to amend grant for design and construction. Scope for design in progress
- General, Special Use, & Grant Funds
 - Project budget \$ 1.3 million
 - ➤ FL DEP Grant awarded \$590,597
 - CHNEP BIL federal grant \$320,000
 - ➤ 402,281 city match (\$98,674 budgeted personnel and \$303,607 contractual)



Tamiami Trail (US 41 NB) Downtown Decorative / Safety Upgrades



- Decorative and safety upgrades enhancing aesthetic appeal and improving safety
- Project is in conjunction with FDOT resurfacing project for upgrades to City design standards. FDOT project currently underway
- Sales Tax Funds
 - 0 \$658,150



Historic District Infrastructure



- Continued efforts to promote & preserve the neighborhood
- Multi-phased approach for design and improvements for new and missing sidewalk connections, decorative and high mass lighting, and drainage improvements
- FY 2025 begin design of sidewalk segments \$348,000
- General, Sales Tax, and Mobility Impact funds
 - \$1.6 million funded
 - \$1.25 million unfunded



Public Safety Building Expansion

- Police Need for additional office space to accommodate growth, including a new training room and additional parking.
- Fire renovate/ reconfigure living and office space to expand administrative space; add on at rear of the building for increased staffing and allow Emergency Management to activate a command center.
- Council direction to look for location to build a new facility for police department
- Needs Assessment Study bids received; evaluation of bids to begin
- Sales Tax and Public Safety Impact Funds
 - Current project budget \$ 6.95 million
 Additional funding may be needed once property is purchased and design of facility is complete

Marina Projects

- (2) 30' Dock replacements Docks delivered prior to Hurricane Ian and installed. These docks were damaged in Hurricane Milton and will need to be replaced.
- 40' Dock needed additional infrastructure; Permit for end support pilings has been approved; Delayed due to hurricane damages.
- Sidewalk: Engineer report received. Sidewalk area needs seawall cap repairs and epoxy injection to level sidewalk.
